**J. Policy Motions**

Motion to condemn Religious Discrimination Bill

**Preamble:** the Religious Discrimination Bill came about in the wake of the 2017 legalisation of same-sex marriage in Australia, as religious peoples and organisations were concerned about this conflict with their beliefs. After conducting the 2018 Report of the Religious Freedom Review, the federal government created a legislation package containing the Religious Discrimination Bill, the Religious Discrimination (Consequential Amendments) Bill, and the Human Rights Legislation Amendment (Freedom of Religion) Bill. The first draft was released in 2019, and on November 24th 2021 the bills were officially introduced in Parliament. They can be viewed [here](#).

Early drafts of the bill received widespread criticism, particularly from queer, disabled, and minority religious groups who were concerned about the bill allowing them to be discriminated against through derogatory and villifying statements, refusal of healthcare, and reduction of workplace protections. The bills have since been reviewed and undergone community consultation. However, the resulting bill is merely a watered down version of the

original - whilst it doesn't explicitly allow for these actions, many people are concerned that it could still be interpreted to allow them.

This bill is not about protecting religious freedom. Rather, it is about affording employers, organisations and even doctors the right to discriminate against marginalised people under the guise of 'religious beliefs.' This has the potential to negatively impact queer people, disabled people, women and people of different cultures, religions and/or ethnicities. Furthermore there are already laws in place, such as the Fair Work Act, which prohibit discrimination on the basis of religion.

Examples of how this bill could be applied, as compiled by [discrimination law experts](#) include:

- An LGBTQIA+ teacher in a religious school who refuses to teach their class that LGBTQIA+ people are sinners could be fired by the school.
- Allowing people to express derogatory or harmful comments in a workplace, school or online setting if they believe their opinions have a religious foundation
- A manager who says that a woman he oversees is a sinner because she is divorced, and that women should submit to their husbands may face no consequences for making such comments

This bill must be opposed. Equality Australia currently has an open letter urging Prime Minister Scott Morrison to put the bill to public inquiry, which can be read [here](#). It has already been signed by a number of organisations, such as Australian Catholics for Equality and various UNSW collectives.

Motion: Australia must stop deporting refugees to danger

**Preamble:** The following is a statement published by the Tamil Refugee Council:  
Prior to the pandemic, almost 50,000 people who had arrived in Australia by plane and whose asylum claims had been rejected were awaiting deportation. Currently, almost 12,000 additional refugees who arrived by boat and hold bridging visas are at risk of deportation. There are several tens of thousands more on other temporary protection visas who cannot settle because the threat of future deportation hangs over them.

Many have fled countries and situations that are unsafe, such as Sri Lanka, Afghanistan, Myanmar and Iran. The dangers are particularly acute for ethnic minorities and political dissidents and activists. In many places, the situation has been made more perilous by the pandemic. Vaccines are in dangerously short supply and civil strife in some countries has increased.

Australia is a signatory to the refugee convention, the foundation of which is the principle that people should not be returned to countries in which their "life or freedom would be threatened". Yet, over the last two decades, Australian governments repeatedly have breached this principle, taking all kinds of measures to deny people's claims and deporting refugees to death, torture, arrest and/or harassment in a host of countries.

This practice must stop. Australia should no longer deport people who have well-founded fears for their safety and well-being.

This MSC moves to publicly call on the federal government to:

- Urgently cease deportations of asylum seekers, both scheduled and underway
- Abolish temporary protection visas and grant permanent protection to all TPV holders to remove the threat of future deportation.
- Release asylum seekers from detention and transit accommodation centres
- Enact an amnesty for asylum seekers currently deemed "unlawful non-citizens".

*Joshua stated that in the middle of a pandemic it is easy to forget other world issues, many of which are worse now. Joshua stated that Motion #12 and #13 are of a similar vein, and that MSC should support refugee rights.*

Motion to condemn the imprisonment of the Park Hotel Refugees

**Preamble:** Since at least February, the Park Hotel in Carlton has had a contract with the federal government to imprison refugees. These refugees were moved here to receive

urgent medical attention under the medevac legislation. Instead of receiving the medical attention they require, refugees have been exposed to torturous conditions inside the hotel. They are denied their freedom and locked up in the hotel, unable to go outside, except for a supervised hour of fresh air; they face regular harassment and abuse from the security guards who monitor them; and most recently, they have all been exposed to COVID-19.

At the time of writing, more than 20 refugees have been infected. There is no ventilation, no air filtration systems and none of the staff have health and safety training. In early November, four guards tested positive to the virus at the MITA processing facility. These horrifically dangerous conditions are only putting the lives of refugees in further jeopardy.

- All refugees detained by the Australian government to be released and granted full citizenship rights, with priority medical access to vaccines and other healthcare services
- The closure of all offshore detention centres
- All refugees to be granted maximum welfare entitlements
- MSA to condemn the imprisonment of refugees

Motion in solidarity with the Sudanese protests against the military coup

**Preamble:** On 25 October 2021, the Sudanese military, led by General Abdel Fattah al-Burhan, took control of the government in a military coup. In the coup attempt al-Burhan dissolved the government and the sovereignty council, suspended critical parts of Sudan's Constitutional Charter of 2019, and imposed a nationwide state of emergency. Since the Sudanese revolution of 2019 the country's government has been composed of a half civilian and half military structure. This month was to see the civilian portion take full control and to finally see the military's official hold over the government end. Al-Burhan's refusal to hand over power to a fully civilian led government has now been met by millions of Sudanese protesting the military's abuse of power and against the coup.

The MSA condemns the actions of the Sudanese military and its brutality and stands in solidarity with Sudanese people in their pursuit of democracy.
