COVID-19 still continues to induce sporadic lockdowns, threaten the employment and economic security of students, provoke added stress and anxiety and disrupt learning. The Academic Safety Net has been integral in mitigating these impacts, and, until a proper vaccine rollout has been achieved, the ASN should continue to be accessible.

Motion regarding a safe & inclusive campus

Preamble: MSA continues to stand unequivocally against any type of discrimination and violence to our students. Equally, MSA reaffirms its stance against all forms of discrimination, violence and harrasment against students on campus. We will continue to prioritise respectful discourse, and the safety and inclusion of all students at Monash University Clayton campus. Moreover, we commit to ensuring that all students who have been affected in any way by the conflict have access to the appropriate support services.

To have also seen a rise in hate speech and threats of violence on campus has been disappointing. MSA has been closely monitoring the situation to ensure that all students on campus remain safe and are treated with dignity and respect, no matter their background. MSA has also been in close contact with University Management, Safer Community Unit and Monash Security to ensure that Monash's Respect Now, Always policy, alongisde its discrimination and harrasment policy, are firmly upheld.
