### Yearly Goals

**Yearly goals for 2026 are due on 15 January 2026.**

### Regular Reports

All office-bearers and division presidents must submit regular reports, aligned with their constitutional duties and role outline, which must include:

- An accurate summary of their actions and achievements since their last report
- A detailed list of goals that can be reasonably expected to be completed by their next report.
- Which of their goals from their last report have been completed or not and why.

## Final Reports

All Office-Bearers and Divisions must submit a final report for the year by the first Thursday of December. The report must include:

- An accurate summary of their actions and achievements throughout the year.
- An evaluation of their list of yearly goals and which of them have been completed or not and why.
- Details regarding their ongoing handover with their corresponding office-bearers-elect.

**Final reports for 2026 are due on 3 December 2026.**

## Other Information

Reports must not include personal attacks on other members of the organisation.

Office-bearers who have returned from conferences where they were participating in the conference within their role as an office-bearer are required to submit a Conference Report to the next meeting of the MSC. Where the next meeting is within a week of their return from conference, office-bearers are permitted to submit their Conference Report to the following meeting of the MSC.

Office-bearers or members of MSA bodies who sit on University Council or Academic Board must submit a report on each meeting of that body to the next meeting of the MSC. Where the next meeting is within a week of the University committee meeting, the office-bearer or member of a MSA body is permitted to submit their report to the following meeting of the MSC.

Everyone required to submit reports to the MSC must have their reports submitted and accepted by the MSC no later than one meeting after it was due.
